The Massachusetts course will be held on January 21,22,23,28 and 29 at Worcester County Horticultural Society's Tower Hill Botanic Garden in Boylston, MA. The Connecticut course will be held on February 10,11,13,18 and 19 at the Jones Auditorium of the Connecticut Agricultural Experiment Station in New Haven, CT.

The course runs from 8:30 to 5:00 each day with six hours of instruction, a one-hour case study, lunch and breaks. The cost for the course is \$350 which includes a course notebook full of handouts and a copy of the newly revised Standards for Organic Land Care. In Connecticut, organic lunches are included. In Massachusetts, organic lunches are available for \$10 a day. The fee for the optional exam and a one-year accreditation is \$150.
